#### Borough Infrastructure Projects

In 2023, the borough was able to accomplish several important infrastructure projects, big and small.

Borough funds were used to seal coat all of Edgewood Drive, Zdina Street. Shirley Drive, and Graham Place as well as portions of Giron Street, Summit Street, Woodland Drive, Eight Street, and Jantosik Street. This seal coat will preserve these streets for years to come.

Community Development Block Grant funds from Westmoreland County were used to fund the installation of new handicap parking spaces at the park/borough building and to make accessibility improvements in the area including repaving that section of the parking lot and installing a new sidewalk in front of the building.

In addition to these larger

projects, the public works crew spent the summer on a variety of projects including rebuilding Hemlock Street, drainage installation on Zdina Street, installing and maintaining storm and sanitary sewers, and regular maintenance activities.

#### Solar Panel Savings

In the summer of 2022, the borough installed 38 solar panels on the roof of the borough garage. The panels entered service in the last two days of August, 2022 once all connections to West Penn Power's system were completed.

Through the November,

2023 billing period, the solar panels have saved the borough just over \$3,600.

The panels were funded using federal funds and funds from a one time revenue source, meaning no borough tax dollars were spent to generate these savings.



## Sanitary Sewer User Fee

At the August, 2023 Council Meeting, ordinance 332 was enacted to establish a sanitary sewer user fee in West Leechburg beginning January 1, 2024.

The fee will be set at \$40 per equivalent dwelling (EDU) unit per quarter. EDU is a technical term that, essentially, means one household or apartment. The number of EDUs for an address was established by a study by the Kiski Valley Water Pollution Control Authority (KVWPCA). This fee only applies to residents connected to public sewer systems, not those who may still have septic systems.

Billing for this fee will be carried out by the KVWPCA on behalf of the borough. This means residents will now receive two separate bills from the KVWPCA for every quarter. One bill will be for services provided by KVWPCA. This is the bill you are already receiving. The second bill will be for West Leechburg's sewer user fee.

The intention is for West Leechburg's bills to be issued at the end of each quarter. Initially, bills will only be payable by check. Additional payment methods may be added in the future. All payments will have to be mailed to KVWPCA, no payments will be accepted at the borough building or through other methods you may use for your regular KVWPCA bill.

#### Why is this fee being enacted?

Much of the borough owned sewer system is reaching the end of its functional life. Terracotta sewer lines and brick manholes are developing defects. Groundwater is infiltrating sewer lines and manholes, increasing the amount of water through the system, causing backups and additional treatment costs. Necessary repair projects have been estimated in the hundreds of thousands to millions of dollars. When the borough seeks grant money or low interest loans, it needs a source of funding to match these grants and loans.

#### I already pay a sewage bill. Why isn't all of this covered already?

The sewer bill already paid by many residents covers the costs incurred by the Kiski Valley Water Pollution Control Authority for transmitting and treating sewage. This includes pump stations and the main sewer treatment plant.

KVWPCA does <u>not</u> maintain the sanitary sewer lines inside the borough. Those lines are the responsibility of the borough and they are now facing the variety of issues outlined above.

#### How was the fee amount determined?

The borough took into account a variety of factors when determining the fee, including: the current loan costs of previous sewer repairs, the current cost of maintenance to the sewer system, pro-

jected costs for additional sewer maintenance (including additional maintenance projects and increased engineering fees), and building a reserve fund to cover future emergency repairs or match potential grant funding. A total was then added up and divided by the number of billable EDUs. This fee was also compared to surrounding municipalities and was lower than many other Kiski Valley communities.

### You talked about repair estimates. Please provide examples.

A recent estimate to completely replace sewer lines on Bosin Street and half of James Street came in at \$1.2 million. A cheaper alternative, to line the pipes (which is not always possible based on the condition of the pipes), was estimated at \$237,000. This is significantly cheaper, but still beyond the current means of the borough.

A recent emergency repair to a manhole and sewer line located in the park cost \$20,000. This repair was on a relatively short sewer line that was not that deep and in an easy place to dig (no street to dig in).

#### What about applying for grant money?

The borough has applied for grant money. For example, the borough was awarded a grant from the county for \$78,870 to be used for a sewer on Gosser Street. The borough was required to provide a match of over \$27,000 for the project. Grants like this typically require matches and the borough will use the new fee to provide matching funds

for future grants.

The borough also applied for grant funds in December 2022 to work on the previously mentioned Bosin/James Street project. As of December 2023, the state hasn't even decided who will receive that grant money. So we are left waiting.

Further, PennVEST, a state agency that provides grants and loans was asked why

the borough is never offered grants. We were told we had to prove rates would increase if there was no grant. Because the borough didn't have a sewer user fee, we couldn't prove rates would increase and could never qualify for grants.

#### Why now?

The borough's sewer

system has multiple defects, including areas that are known to have sags, allow major water infiltration, or have design issues. Working to fix this issues now will precent worse issues (collapses, blockages) in the future. Council is choosing to be proactive and address the issue now.

#### **Burning Reminders**

As a reminder to all residents, the following regulations apply when burning in the borough.

- ONLY WOOD or WOOD PRODUCTS (ex: boxes or paper) may be burned.
- No burning between dusk and dawn. All fires must be completely extinguished (no smoking or smoldering) by sunset.
- Only cooking fires (those for picnics or cookouts) may burn on Sundays and Mondays. NO garbage fires on Sundays or Mondays.
- DO NOT burn tires.
- You must burn in a noncombustible container with a screen on top. No open pits.

- If you need to burn on a large scale, you must obtain a permit from Fire Chief Chris Swank who can be reached at 724-980-4761. There is no permit fee, but the permit will be issued for a specific day and time.
- Please consider the effects the smoke you create has on your neighbors and be considerate of them.



#### Garbage Collection

The borough contracts with Bankosh Sanitation for collection every Tuesday. Please take note of the following regulations/requirements.

- Each residence is limited to 3 thirty (30) gallon garbage bags.
- Anyone with additional garbage must contact
   Bankosh at (724) 461-4185 to pay for and obtain stickers allowing for extra garbage.
- Please place garbage at the street on Monday night, Bankosh starts early on Tuesday.
- The garbage collector has final discretion over what they collect.

#### Garbage Ordinance

In July, ordinance 331 was enacted regulating the keepborough.

This ordinance requires that garbage be placed in a receptacle with a closed lid and not placed at the curb until the time of collection.

Additionally, the keeping of rubbish and junk is prohibited. (Examples (not a com-

plete list): papers, rags, cartons, boxes, wood, rubber, ing of garbage and junk in the leather, plastic, tin cans, metals, mineral matter, glass, crockery.)

In 2021, West Leechburg was required to pass a stormwater management ordinance. Please be aware that under the terms of this ordinanace, building projects you may undertake (new houses, driveways, and others) may require a stormwater management permit.

# Building Permits

If any resident sells their house, it must be dye tested to prove it is properly connected to the sewer system. If a dye test is not provided, a municipal no lien letter will not be issued.

The dye test MUST be done by a borough authorized plumber, listed below. The test will not be accepted if it comes from another plumber.

When planning to construct new additions/ structures on your property (such as fences, sheds, decks, pools, garages, additions, etc.) please contact Building Inspection Underwriters (BIU) at the number provided.

BIU will determine what types of permits you might need and will guide you through the process of obtaining said permits.

## Clean-Up Days

Due to increasing costs, the borough will no longer be able to provide clean-up days for residents. Costs more than quadrupled from \$1200 to \$5000 on top of a regular garbage bill that increased by more than \$10,000.

Our garbage contractor, Bankosh Sanitation, sells stickers that may be placed on additional items/ large items of garbage for pickup.

# Vard Waste and Snow solici

It is unlawful, and dangerous to discharge yard waste (leaves, grass clippings, etc.) or snow onto borough streets.

These discharges are prohibited as they create a hazard for road users, especially pedestrians, cyclists, and motorcyclists.

Additionally, a new ordinance was passed in 2023 prohibiting the discharge of yard waste onto/into catch basins, ditch lines, and manholes within the borough.

This new regulation was created to prevent blockages and maintenance difficulties with the borough storm and sanitary sewer systems.

There is <u>NO</u> soliciting in the borough without a permit. Any individual, group, or business going from house to house must have a soliciting permit.

The permit will be issued by the mayor and may require a fee to be paid. Solicitors have to provide documentation to obtain the permit.

Residents should ask to see solicitation permits. If a solicitor does not have a permit, please notify the police department immediately. This is a safety and security measure for our community.
